SOUTHCO, INC. NORTH AMERICAN ROUTING GUIDE

1. General Guidelines

- A. Freight charges which are Prepaid and Added to your invoice will not be accepted.
- B. Material ready to ship on the same day must be consolidated under one Bill of Lading and shipped together as one shipment.
- C. The maximum weight per carton is not to exceed 35 pounds; or if this requirement is not feasible, the weight is to be clearly marked on the outside of the container.
- D. All shipments must be accompanied by a complete packing list secured to the outside of a master carton and any other documents specified in the Purchase Order.
- E. All *Southco* Purchase Order Numbers must be referenced on a bill of lading or airway bill.
- F. The "Due Date" shown on our purchase order or advised by a *Southco* Buyer is the date material must arrive at our respective locations. Air freight or other premium transportation services used to meet the required "due date" will be your responsibility.
- G. The use of airfreight or any type of "premium" transportation services must first be approved by a *Southco* Buyer or shipped at your expense.
- H. Any deviation to these guidelines will result in the chargeback of all freight charges to your Company.

2. International Shipments

For materials over 150 lbs, shipping from locations outside of the U.S, please contact your local DHL Global Forwarding office for instructions. Before calling, please have the number of cartons, gross weight and dimensions of the shipment ready.

3. Ground Shipments

- A. Any total shipment **weighing 150 pounds or less** is to be shipped via UPS Ground. Please provide UPS with the respective Southco Ground Account Number (there is an account number for each destination) as provide by Buyer. Shippers are **not** to show any Declared Value for Carriage on any UPS shipping document, way bill etc.
- B. Shipments **weighing over 150 pounds to 15,000 pounds** are to be routed using the Carrier shown on the Designated Carriers for North America list below. Simply select the Carrier based on your shipping point. If the Carrier listed does not service your shipping location, please call (610) 361-6344 for further instructions.
- C. For shipments **weighing over 15,000 pounds**, please call (610) 361-6344 for instructions.
- D. Southco uses the services of a freight bill payment service. All Collect and Third party bills of lading must be marked:

4. Air Shipments

A. Contact the respective *Southco* Buyer for routing and billing information.

B. Please use the UPS Account Numbers provided by the Southco buyer . The Southco Buyer will determine what level of service is required. UPS WW Saver is standard service. The Premium Services are Next Day Air early AM or Second Day Air Package.

Next day delivery - UPS Next Day Air

2nd day delivery - UPS 2nd Day Air
